The pressure will potentially fall on everyone whether in City, Town, Village or Hamlet. Dickleburgh and Rushall Parish Council are responding to this growing demand on a number of fronts. The development of a Neighbourhood Plan is one of those responses. By creating a NP we will be able to identify the priorities of the residents of the parish and ensure they are properly observed.

We need your views in order to properly reflect your concerns and aspirations. There are no wrong answers to these questions and if you want to provide thoughts on areas not covered by these questions please do so. All responses will be taken account of.

Message from the Parish Council

The proposal to create a Neighbourhood Plan for the villages and surrounding environs has been submitted to South Norfolk along with a map showing the designated area which is the parish boundary. The Dickleburgh and Rushall Neighbourhood Plan will give people in our two villages greater control over the way we grow and develop - how many new houses are built, and where they should be, what we do about transport problems, the infrastructure and environment in and around our villages, and so on. Without a Neighbourhood Plan, we are largely in the hands of the district council planning office and of developers.

It can only work with your support. South Norfolk will only accept a Neighbourhood Plan if it represents the wishes of residents.
