117. ADJOURNMENT OF THE MEETING FOR PUBLIC PARTICIPATION, COUNTY AND DISTRICT COUNCILLORS -

Co. Clir. Dr. C. Rowett - the report is attached in full in the paper minutes file topics included: water & flooding; Norfolk Winter for advice from the County Council to beat cold; the Devolution Deal was discussed at the December meeting, there are various options including encouraging Councils to take on additional responsibilities, with financial support over a period over time. The recommendation was a level 3 deal be accepted, involving a number of responsibilities and financial implications, delayed over a longer period of time - a number of doubts were raised as the funds offered will not be index linked, not all Councillors voted in favour, the discussion continues.

NCC bus service from Dickleburgh to Norwich has been cut, although an alternative service to support has been agreed, this does not make provision for a free bus service to the Doctor's Surgery, in Pulham Market although minimal service for community, the Parish Council would like to see it reinstated. The County Council are proposing a car service to replace bus services, the cost to the passenger would include the cost of petrol from Norwich to pick up the customer – this is considered, by Co. Cllr. Dr. C. Rowett to be unacceptable – further discussions to be held.

The Long Stratton by pass should be started in near future - a question was raised as to whether all archaeological evidence is being recorded and is protected - Co. Cllr. C. Rowett will check through the surveys to ensure that everything is recorded correctly;

The Norwich Western Link Road – the cost of the build has risen, there will be significant damage to environment so there is a possibility it may be prevented;

Any traffic, flood, or highways problems can be reported to the County Council website. **Dist. Cllr. C. Hudson** - will check if the 'Winter Pressure' grant has closed - it appears to have been closed when an attempt to apply was declined by a Parish Councillor; the recent flooding indicated that 20mm had fallen very quickly, all cases of flooding should be reported to the Flood Management team. In October the Government made an allocation to assist residents and business, via Council Tax relief, up to £500 – Dist. Cllr. C. Hudson will send details to the Clerk;

South Norfolk Council will set their precept in mid-February, this was frozen last year, any comments should be submitted to him.

A new 'Men's Shed' in the Pulham's is being launched at the Pennoyers Centre on Sat. 27th January, 10.00 am – 12 noon. It will be based at South Green - community activities, learn/share new skills, further details can be found on Dist. Cllr. C. Hudson's website/Twitter feed;

The Planning Application on the edge of Dickleburgh Moor, Norwich Road has been rejected on two other occasions, Cllr. C. Hudson's comment to the Planning Officer will result, if the Officer is mindful to reject the application, in the application being heard in Committee - comments from all parties will be made in a public forum at the Council Offices in Norwich.

Dist. C. Hudson will make representation, Dist. Cllr. D. Thompson will not comment as he is Deputy Leader of Planning, and feels he should not he comment on local applications so that he can hear such applications in full;

Question from Councillor - the closure of Diss Pool for 12mths - there was no consultation, it was an announcement just prior to closure. This comment was noted by Dist. Cllr. C. Hudson. The gym is being moved out of Diss Leisure Centre to a potential new site with multi-function usage.

Dist. Cllr. D. Thompson's - thanked all volunteer groups; the Town Parish Forum meets later in the week – there is an opportunity to raise any queries at the Q & A sessions towards the close of the sessions. The Clerk has details for these regular sessions.

Flooding areas in the locality - (i) a property on Lakes Road, which flooded in 2021 via the ditch opposite, has recently flooded again, support and assistance from neighbours helped to stem the damage;

(ii) The bottom of Pulham Road, near the Rushall junction has had deep water for a number of weeks, which has not drained away, and there has been evidence of raw sewage in the water. Highways have attended recently and drained the area. There is a possibility that there may have been a stream/ford at this point in past years, and with the weight of heavy lorries over the years it has damaged the piping underneath, thus requiring further works to be carried out;

(iii) Ipswich Road flooded again close to the junction with Harvey Lane, there is evidence that further up Ipswich Road of undergrowth and saplings growing in the ditch needing to be cleared, to encourage the flow of water; a complaint was sent to the County Council, but the officers were busy It was pointed out is also hazardous at night;

It was noted that the County Council were clearing and creating a number of grips around Rushall village on the day of the heavy rain/floods, which instead of diverting water into the ditches, resulted in the water from the ditches flooding back onto the roads.

Cllr. C. Hudson mentioned that the use of leaky dams is being promoted throughout the County. There have been a number of successful projects in the Shimpling and Thorpe Abbots area, using this method.

The Riparian Officer is Nathan Harris - he may be able to offer advice, along with advice to landowners, whilst reminding them of their responsibilities/riparian rights;

It was agreed that a reminder would be included in the next edition of the Parish News using the information from the leaflet published in 2021 – **ACTION** - Clerk to update and send a copy for the back page of the News.

(i) Precept for Financial Year 2024 – 2025 - The tax base has risen to 546 homes, it was recommended that a charge of £70.65 remain for Band D properties. This will generate a precept of £38,575.00. It was resolved to approve the Precept for 2024 – 2025, proposed Cllr. J. Kerr, seconded Cllr. D. Leyserman, unanimously approved

It was noted that this figure formed the basis for the Budget 2024/25 which was approved at the December meeting, item 105b (ii)

- **c.** Approval of the quarterly bank reconciliation the third quarter Sept. Dec. 2023 proposed Cllr. D. Leyserman, seconded Cllr. S. Johnson, all agreed
- **d. Cost of projector the** Clerk presented two recommended projectors, it was suggested that further research into adding a decent sound system/additional speakers, type of picture resolution would be beneficial ACTION Clerk to circulate.
- e. Brown Bin email sent to 'Waste Administration at Ketteringham, this has been actioned
- f. SNBC 'Winter Pressure' grant offer Cllr. P. Reekie went to the South Norfolk and Broadland Council website SNBC), the SN applications had been closed - presumably all the grants had been allocated. ACTION - Dist. Cllr. C. Hudson and Cllr. P. Reekie will liaise – item 117
- **g. Maintenance around the villages -** the Clerk has met with Hadleigh Drake, Hadleigh will send proposal. **ACTION** A similar conversation/meeting with Neil Shannon will be arranged, both will be invited to meet with a couple of Councillors prior to the February meeting, with a recommendation.

- **125. RECENT CONCERNS REGARDING WET WEATHER** some details mentioned in item 117 Burston Road, Ipswich Road, Norwich Road, Pulham Market Road, Harvey Lane. Rectory Lane – before Christmas the local landowner dug a trench, which helped to divert the water from the two houses on Rectory Lane, the situation occurred again last week, neighbours assisted in building an earth bund;

It was suggested that an informal meeting of farmers/landowners, residents who had knowledge of the locations in the Parish where flooding occurred, could collate information and advice on strategies within the Parish, looking at pinch points, some of the natural low points etc. in days gone by there may have been ford within the Parish/Villages. The evidence and a direct line of communication may assist in communicating information to Norfolk County Council re-issuing flood advice. **ACTION** - the previous flier to be checked and updated information, Cllr. S. Johnson will liaise with the Parish News for it to be printed on the back cover facing outward, copy to be placed on the Village Shop noticeboard and on the website.
